



Corona Pony Managers/Coaches Code of Conduct

The Board of Directors of Corona Pony Baseball has adopted the following Code of Conduct for Managers, Coaches, and Assistant Coaches that are assigned to teams participating in Corona Pony league games, events, and activities.

The Corona Pony Baseball Board of Directors is committed to ensure the best possible baseball experience for the members of our league. The Corona Pony Baseball program is designed to provide an experience that is positive, safe, developmental, and fun for the players.

The team Managers/Coaches, as representatives of Corona Pony Baseball shall, by his or her actions and conduct, set an example for the players under his or her care. The Board of Directors of Corona Pony will take a stance of **ZERO TOLERANCE** in the event of a violation of the Manager/Coaches Code of Conduct.

Managers/Coaches shall adhere to the following code of conduct:

1. Managers/Coaches will lead by example and will encourage good sportsmanship by demonstrating positive support for all players, managers, coaches, umpires, and league officials at every practice, game, or league event;
2. Managers/Coaches shall treat each player as an individual, taking into consideration the wide range of emotional and physical development that may exist for players on the same team;
3. Managers/Coaches shall not use profanity at any time during a game or practice or within the presence of any player on any team;
4. Managers/Coaches shall treat players, other managers/coaches, umpires, league officials, parents, and spectators with respect;
5. Managers/Coaches shall not abuse equipment or facilities in an obvious display of anger;
6. Managers are responsible for submitting accurate uniform orders for their teams. If an incorrect order is submitted, the manager will be responsible for the associated replacement fees. Failure to pay the replacement fee will result in suspension until the fee is paid.
7. Managers are responsible for submitting their spring team sponsorships by the designated deadline. Failure to meet this deadline will result in suspension until the sponsorship is submitted.
8. Managers/Coaches shall do their best to provide a safe playing situation for players;

9. Managers/Coaches shall not verbally abuse, threaten or engage in tortious physical contact with any player, coach, manager, spectator, umpire, league official, parent, or other individual under any circumstances;
10. Managers/Coaches shall use coaching techniques that are appropriate for the skills being taught;
11. Managers/Coaches shall not use tobacco or vaping products on the field during any practice or game.
12. Managers/Coaches shall not be under the influence of alcohol or other intoxicant at any time while coaching, attending an Corona Pony event, or while otherwise representing Corona Pony Baseball;
13. Managers/Coaches shall follow badge policies and have them visible during all games.
14. Managers/Coaches shall not use prohibited noisemakers or music during the course of the game.
15. Managers/Coaches shall be knowledgeable of the rules of baseball within the divisions that they coach and shall teach these rules to the players;
16. Managers/Coaches shall follow the rules, regulations and policies of the Corona Pony Baseball league and PONY Baseball, Inc.
17. Managers/Coaches shall not conduct themselves in any manner detrimental to Corona Pony Baseball or to PONY Baseball, Inc.

Violation of this Managers/Coaches Code of Conduct or the Corona Pony Code of Conduct may result in disciplinary action against the violator, which may include any of the following; ejection, probation, suspension, dismissal & barred. Please review our general code of conduct and disciplinary policy.
